Requirement for Set up a Germany Company

As a form of capital company, The limited liability company GmbH is equivalent to a legal person with 25,000EUR registration capital at least.

The Advantage of Germany Company

- b) Complete corporate profits and tax budgetary plan yearly by German veteran accountants.
- **5.** Assessment and Registration in local German:
- a) Finish company economic prospect evaluation in local German IHK;
- **b)** Finish company name and business scope evaluation;

- c) Finish the evaluation on work permit to be obtained by legal representative in local **Arbeitsamt**; Requirement for set up a Germany Company;
- d) Finish the long-term investment visa evaluation on legal representative in local Ausländerbehörde;
- e) Submit documents to the local German notary and court, including company inner shareholders?equity, Articles of Association and Appointment Letter for Legal Representative;
- f) Pre-registration in local German notary and court temporarily;
- g) Pre-registration in local German Finanzamt.
- 6. Return German evaluation documents to China (only for people who need visa from German Embassy in China):
- a) Prepare relevant documents;
- b) Submit documents to the German Embassy in China;
- c) Apply for the 90-day short-term transit visa.
- 7. Post-registration:
- a) Transact bank account opening and capital injection;
- **b**) Change the long term German investment visa;
- c) Finish registration in the local German Gewerbeamt and obtain the business certificate;
- d) Finish the official registration in local German notary and court;
- e) Finish the official registration in local German Finanzamt and obtain the tax code;
- f) Finish the Zollamt registration and obtain the import and export code;
- 8. Our service ends up.
