Germany Company Incorporation Package#2_Registered Office and Local Representative

Requirement for set up a Germany Company

As a form of capital company, the limited liability company GMBH is equivalent to a legal person with 25000EUR registration capital at least.

The Advantage of Germany Company

- **a.** It is good to service local clients, as some local clients or suppliers only would like to contact the companies registered in Germany, not overseas:
- b. Promoting the products and the company value, and the sale price could be a bit low to the market price in Germany;

INCORPORATION COST

- 1) Our quotation for registering a Germany Company (GMBH) is 5,700EUR.Our service contains:
 - Free consult service in advance;
 - Equity of shareholder and article of association of the Germany company;

 - Assist to legalize the relevant documents about the registration of Germany company;

Registration time

- 3) The investor provides information such as personal or corporate management plan.
- 4)Fulfill the Business Plan according to IHK (Internationale Handel skammer)and Ausländerbehörde in Germany:
- a) Compose Business Plan by Germany veteran lawyer;
- b) Complete corporate profits and tax budgetary plan yearly by Germany veteran accountant;
- 5) Assessment and Registration in local Germany:
 - Finish company economic prospect evaluation in IHK;
 - Finish company name and business scope evaluation;
 - Finish evaluation on work permit to be obtained by legal representative in local Arbeitsamt; (it can be skipped if we provide service for local legal representative.)
 - Finish the long-term investment visa evaluation on legal representative in local Ausländerbehörde; (it can be skipped if we provide service for local legal representative.)
 - Submit documents to the Germany notary and court, including company inner Shareholders?equity, Articles of Association and Appointment Letter for Legal Representative;
 - Pre-registration in Germany notary and court temporarily;
 - Pre-registration in Germany Finanzamt.
- 6) Return Germany evaluation documents to China (for people who need visa from Germany Embassy in China):
 - Prepare relevant documents;
 - Submit documents to the Germany Embassy in China;
 - Apply for the 90-day short-term transit visa.
- 7) . Post-registration:
 - Transact bank account opening and capital injection;
 - Change the long term Germany investment visa;
 - Finish registration in the Germany Gewerbeamt and obtain business certificate;
 - Finish the official registration in Germany notary and court;
 - Finish the official registration in Germany Finanzamt and obtain the tax code;
 - Finish the Zollamt registration and obtain the import and export code;
- 8) Our service ends up.
- 9) The company opens.
- 10) We continue to provide business service in Germany.
