#### Set-up Requirements for Formation of Private Limited Company

- Minimum 1 Shareholder + 1 Director + 1 Company Secretary
- Shareholders may be corporations or individuals
- At least one Director must be a resident of Singapore. i.e. Singapore Citizen/ Singapore Permanent Resident (PR)/ Singapore Employment Pass Holder (We can act as your company's local nominee Director, if required, for a fee)
- The Shareholder can also act as Director
- The Company Secretary has to be Singapore resident
- Sole shareholder and director cannot act as Company Secretary
- Minimum initial paid-up share capital is S\$ 1.00
- A Singapore Private Limited Company must have a Registered Address in Singapore
