Qatar Trademark Registration Costs and Registration Procedures

1. Qatar Trademark Registration Fees

Services	Fees (USD)
Step 1: Pre-filing Search	
Word mark (each class) (Internal Database)	360
Device mark (each class) (Internal Database)	360
Official search (each mark)	675
(1) Pre-filing search is not compulsory in Qatar. (2) Pre-filing search is limited to Qatar Intellectual Property Office's database only. (3) Pre-filing search report delivered in 15 working days by email.	
Step 2: Trademark Registration Request	
Each class	810
(1) Fees covers both our service fees and official filing fees; (2) Fees for trademark registration request listed above cover not more than 20 items of products or services in each class. Each item in excess of 20 will be charged with an extra fee of USD10. (3) Multiclass applications are not permitted by Qatari Trademark Law. Each class of goods or services are considered to be an independent application.	
Step 3: Publication	
Each class	180
Step 4: Final Registration/Certificate	
Each class	1,315

Note:

- (1) The fixed fees quoted above apply only to trademark applications which are unopposed and proceed without complication.
- (2) All fees quoted above do not include delivery fees.

- (3) The fee for Translation of the list of goods from English to Arabic (over the first 100 words) per page is USD45
- (4) The fee for claiming convention priority is USD55
- (5) Goods in class 33 and alcoholic beverages in class 32 are not permitted to register as per Qatari Trademark Law.
- (6) The protection of the class cannot include all goods and services for classes 1, 4 to 7, 10 to 14, 16 to 22, 29 and 31, as they are not entirely granted by the trademark law; one item must always be excluded from these classes.

2. Calculation of Registration Costs

Example 1: One mark one class

If you want to apply to have your trademark "ABC" registered in Class 25 (clothing, footwear, headgear), that is, one mark one class, the total fees for both trademark pre-filing search and registration request and certificate are:

Pre-filing search: USD 360

Request for registration: USD 810

Publication: USD 180

Final registration/Certificate: USD 1,315

TOTAL: USD 2,665

Example 2: Two marks one class

If you want to apply to have your trademarks "ABC" and "DEF" registered in Class 25 (clothing, footwear, headgear), that is, two marks one class, the total fees for both trademark pre-filing searches and registration requests and certificates are:

Pre-filing search: $360 + 360 = \text{USD } 720$

Request for registration: $810 + 810 = \text{USD } 1,620$

Publication: $180 + 180 = \text{USD } 360$

Final registration/Certificate: $1,315 + 1,315 = \text{USD } 2,630$

TOTAL: USD 5,330

The costs illustrated in the examples above are based on the assumption of a smooth application, that is, no objection being raised by the trademark office or any other third party. Also, the costs

stated above exclude courier charges for sending the Power of Attorney and delivery of Certificate of Registration upon acceptance of registration.

It is further assumed that the number of items of products included in each class is not more than 20. Each additional item after the first 20 is charged at a fee of USD10.

3. Materials Required for Filing of Trademark Application in Qatar

- (1) A Power of Attorney legalized up to the Qatari Consulate or any other Arab consulate.
- (2) A duly completed trademark search/registration order form (to be provided by Kaizen).
- (3) A soft copy of the trademark in JPEG format.
- (4) A copy of identity proof of the applicant (passport for individuals and business registration licence/certificate for corporation).
- (5) A copy of the priority document, in case priority is claimed.

4. Qatar Trademark Application Procedures

- (1) Client sends to Kaizen (by email or fax or post) a specimen of the trademark together with the duly completed Trademark Registration Order Form and at the same time make payment for the pre-filing search;
- (2) Kaizen acknowledge the information like the mark, goods/services and apply class(es), then we will provide the latest quotation and preliminary advice;
- (3) Client confirm the quotation and make formal entrust. Kaizen will conduct the pre-filing search (if requested). The official search report will be sent to client within 15 working days;
- (4) If the search results indicate that the application is likely to be accepted and client decide to proceed. Kaizen will file trademark application to Intellectual Property Department when we received the payment of application fee and instruction;
- (5) Intellectual Property Department will conduct a search of the trademarks records to see if the same or similar trademark has already been registered or been applied for by another trader in respect of the same or similar class of goods and services. They will also see if the trademark satisfies the registration requirements laid down in the Trade Marks Ordinance. If the requirements for registration are not met the Examiner will object to the mark.
- (6) Once your trademark has been accepted for registration, it will be published on the journal for 4 months.

- (7) If no objection by a 3rd party, a registration certificate will be issued by Intellectual Property Department. The certificate will be sent to client when Kaizen confirmed the information and contents are correct.

5. Time scale

Currently it takes around **16-24** months to get a trademark registered in Qatar in a smooth case.

6. Payment Term and Payment Method

Our fees for each stage of an application are to be invoiced and settled before the commencement of each stage of service.

We currently only accept Hong Kong Dollar cheque, cash or TT and credit card through Paypal. **Please click here for payment methods.**

7. Refund Policy

No refund of fees will be made after the commencement of services. For example, if we have already performed the pre-filing search and the search results indicate that there is an identical mark already in the register and application for filing should not be proceeded, the fees for pre-filing search will not be refunded. Or we have already filed an application and the application is being objected and refused by the trademark office or any other party, then there will not be any refunded of fees.

In any case you pay us our fees for all three stages of an application, and the search results indicate that there is an identical mark already in the register and application for filing should not be proceeded, then the fees for services not performed, i.e., filing for application and issuing of certificate of registration will be refunded.
